The upcoming plant of Chennai-based Polymatech Electronics will be spread over

Special incentives have been offered to the semiconductor industry in the state's new industrial policy, which will help attract investment in the sector, he said.

Countries which have become developed created a favourable environment to enable rapid technological progress, Sai "Now 6G and 7G technologies are

coming, and I am happy that the chips required for these technologies will be made in our country, and our engineers will make them in Nava Raipur," Sai added. During an investor connect programme

organised in Delhi in December, state officials met the management of Polymatech, and the company expressed a desire to invest in Chhattisgarh, he said.

The semiconductor plant, to be set up at a cost of Rs 1,143 crore, will manufac-



ture advanced technology Gallium Nitride (GaN) semiconductor chips enabling the working of 5G and 6G technologies in Chhattisgarh.

It will have a production capacity of 10 and power electronics.

Congress to protest from Apr 18 against rape, murder of minor girl

The opposition Congress party in L Chhattisgarh will take out a foot march from April 18 to 21 in a protest against the rape and murder of a minor girl in Durg district.

The foot march, named 'Nyay Path', will start from Durg and will culminate in Raipur, where Congress workers will gherao the residence of Chief Minister Vishnu Deo Sai on April 21, state party chief Deepak Baij told reporters on Friday.

An innocent girl was raped and murdered on the ninth day of the Navratri festival when Kanya Bhojan was being held all over the country, which makes the soul tremble on hearing about the brutality that happened to the innocent girl, Baij said.

Daughters, sisters, and mothers are not safe. Incidents of rape are increasing, and criminals have become unbridled and have no fear of the law in the present BJPruled Chhattisgarh, he said.

He added that the chief minister and home minister were not worried about the deteriorating law and order situation.

The state government has failed to provide a safe environment for women, whereas the public has lost faith in them and the police. That's why the house of the suspected rape accused was set on fire, he



A six-year-old girl was sexually assaulted and murdered in the Mohan Nagar area on Sunday by her uncle in Durg district.

She had gone to her grandmother's house in the neighbourhood for a function on the ninth day of the 'Navratri' festival when her 24-year-old uncle sexually assaulted her, killed her and later placed the body in a neighbour's car.

The Durg district bar council has already announced it would not represent the accused in court.

The Yadav community, to which the vic-

tim belonged, has demanded a probe by the Central Bureau of Investigation (CBI) into the incident and submitted a memorandum to the Durg collector, seeking Rs 50 lakh assistance for the girl's mother and a government job for her.

Also, an eight-member Special Investigation Team (SIT) was constituted on Wednesday by Durg Police to ensure a speedy probe into the incident.

The SIT will complete the investigation as soon as possible and submit the chargesheet in the court.


