

# ‘Bastar emerging as a gateway to a new India’

Chhattisgarh Chief Minister Vishnu Deo Sai said on Wednesday that Bastar was emerging as a gateway to the possibilities of a new India.

He said this while reviewing the development works of Bastar division in Jagdalpur city. Deputy Chief Minister Vijay Sharma was present.

Sai added that in-depth discussions were held on the development of the Bastar division, peace establishment and progress of welfare schemes.

He told officials to give priority to backward castes, women and local youth to help them progress towards employment and self-reliance.

The disruption in providing services like Aadhaar, ration and banking will be resolved soon by coordinating with the concerned agencies, he said.



He also asked officials to run regular buses in rural areas, emphasising the need to strengthen the transport infrastructure. "The development journey of Bastar

now demands continuous speed. Our effort is to ensure that the benefits of the welfare schemes reach every beneficiary," he said.

"The overwhelming participation of the people in cultural activities like Bastar Olympics and Bastar Pandum is proof that they want to connect with development and want to distance themselves from Naxalism," he said.

Bastar Division Commissioner Doman Singh briefed about the progress of the development works—87.24 percent target under Ayushman Bharat Yojana registration and 96.37 percent in Aadhar card making have been achieved.

Electricity has reached 95.89 percent of houses. Electricity connections have been provided to 100 percent houses in Kanker district, while in Bastar and Kondagaon districts this figure has crossed 99 percent and 91.55 percent target has been achieved under the Kisan Credit Card Scheme.

## Congress protests over ED's action against top leaders

The Congress in Chhattisgarh on Wednesday staged sit-in protests in all districts of the state over the Enforcement Directorate's (ED) chargesheet against top leaders.

The ED has filed a chargesheet against former Congress President Sonia Gandhi, Leader of the Opposition Rahul Gandhi and others over the alleged money laundering in the

National Herald case.

AICC General Secretary and former Chhattisgarh Chief Minister Bhupesh Baghel said at the protest site in Raipur that this action was intended to intimidate and defame the Congress leaders.

ED's job is to take action against those who use illegal money, but they only target opposition leaders. The central agencies work at the behest of the BJP government, he alleged.

Former Deputy Chief

Minister T.S. Singh Deo said that the ED's action cannot be condemned enough.

The BJP is frustrated and is hatching false conspiracies against the Gandhi family, he alleged.

Filing a money laundering case against a not-for-profit company proves this, he said.

Congress workers are not going to be scared from this conspiracy and stand together shoulder to shoulder, he said.

## 14 held for facilitating online betting

Chhattisgarh police have arrested 14 persons from West Bengal and Assam for facilitating online betting through Mahadev app panels, they said on Wednesday.

Of the arrested, three hail from Jharkhand, two from Madhya Pradesh, one from Punjab, one from Uttar Pradesh, one from Bihar and six from Chhattisgarh.

The police arrested Nikhil Wadhvani, who was engaged in online betting, on April 13 in Raipur.

They tracked down the 14 operators by interrogating Wadhvani and through the technical analysis of his electronics.

The police conducted raids and nabbed eight accused from Kolkata and six from Guwahati.

The police seized 67 mobile phones, eight laptops, four routers, 94 ATM cards, 15 SIM cards, 32 bank passbooks, three bank cheque books, one security



camera, and their betting records from Sections 336, 338, and 340 of the Bharatiya Nyaya Sanhita.

## Four smart industrial parks to come up in Chhattisgarh

Chhattisgarh Chief Minister Vishnu Deo Sai on Wednesday announced an allocation of Rs 445 crore to set up four smart industrial parks in the state.

He announced it at an event in Raipur. The newly appointed Chairman of Chhattisgarh State

Industrial Development Corporation Limited, Rajiv Agarwal, took charge.

Of the RS 445 crore, Rs 350 crore will be invested to set up an electronic manufacturing cluster on 322 acres in Rajnandgaon district, Rs 25 crore for a astronomy related manufacturing cluster on 50 acres in Bijetla village in Rajnandgaon dis-

trict, Rs 30 crore for a readymade garment park on 20 acres in Nava Raipur and Rs 40 crore for setting up a furniture cluster on 30 acres also in Nava Raipur.

On this occasion, Sai spoke about the investment proposals of Rs 4.50 lakh crore that have been received and the availability of adequate resources for industries to flourish.

### Panic erupts over bomb threat against Kabirdham collectorate

A bomb threat against the Kabirdham Collectorate caused a stir there on Wednesday.

Kabirdham Superintendent of Police Dhamendra Singh Chhwai said that the threatening message was sent to the official email ID of Kabirdham Collector Gopal Verma.

After which a senior officer was sent to the spot along with the Bomb Disposal Squad (BDS), Sniffer Dog Team, LMV vehicle, QRT team and police force, he said.

Senior police officers monitored the entire operation. The police did not find anything suspicious or any dangerous material anywhere, he said.

Preliminary investigation revealed that the mail was false and misleading and intended to scare the people, the police said.

Superintendent Chhwai urged the people to not pay attention to rumours, be alert and immediately inform the police about any suspicious activity.

Action is on with the help of the cyber cell to track whoever sent the threatening email, he said.
