Shivakumar gives 'Raj Bhavan Chalo' call to press Governor for action in pending cases



Bengaluru, Aug 27 (IANS): Karnataka Congress President D K Shivakumar on Tuesday gave a 'Raj Bhavan Chalo' call for an agitation on August 31 to pressurize Governor Thawar Chand Gehlot to give sanction for prosecution in cases against BJP leaders pending before him. The Congress has been protesting against the Governor for giving sanction for prosecution against Chief Minister Siddaramaiah over alleged irregularities in the Mysuru Urban Development Authority (MUDA). Addressing media persons at the party office, Deputy Chief Minister Shivakumar stated on Tuesday, "On August 31, we will take out a march from the Gandhi statue in Vidhana Soudha to the Raj Bhavan and urge the Governor to accord consent for the pending cases seeking prosecution. All legislators, ministers and council

members should participate in the agitation," Shivakumar maintained. Criticising Union Minister for Heavy Industries and Steel, H D Kumaraswamy, the Deputy CM stated, "Our big brother Kumaraswamy is someone who does genuine work. A case was registered against him 10 years ago. On November 21, 2023 Lokayukta SIT officials also wrote a letter to the Governor. We are not fabricating anything. The SIT has submitted a 218-page investigation report to the Governor against him. Taking a jibe at the Union minister, he further questioned, "Kumaraswamy, who is well-known for truthfulness, said that he didn't sign anything. I was surprised by his statement. If he claims that it's not his signature, then someone must have committed forgery. Why hasn't he filed a complaint alleging signature forgery? If his signature was indeed forged, shouldn't he have at least filed a complaint with the police?" Shivakumar was referring to the case of alleged illegal allotment of more than 500 acres of land for mining during Kumaraswamy's tenure as the CM. "Whoever has done it, a complaint should be lodged against those who committed the forgery," Shivakumar maintained.

BJP uncovers KIADB land allotment irregularities favouring Kharge family

Bengaluru: Leader of the Opposition in the Karnataka Legislative Council, Chalavadi Narayanaswamy, on Wednesday alleged that the Congress government had conducted an "illegal and rushed" land allotment process through the Karnataka Industrial Area Development Board (KIADB). He accused the government of "circumventing" legal procedures to benefit AICC President Mallikarjun Kharge's family, including his son and incumbent minister Priyank Kharge and three other relatives. Priyank Kharge and state Large and Medium Industries Minister MB Patil have already rubbished the allegations.



Narayanaswamy slammed the government for what he called a "blatantly irregular" process, highlighting that the KIADB land was allocated in just 14 days—a timeline, he claimed, was far too short for such a significant decision. "The process to allot KIADB land was rushed through without proper scrutiny, taking only 14 days when it should have taken at least a month to ensure transparency and due diligence," he told reporters in a press conference. Narayanaswamy questioned the "motive" behind the "accelerated timeline", alleging that it was orchestrated to "benefit" the Kharge family at the expense of public resources. At the heart of Narayanaswamy's allegations is the claim that several plots, originally designated for auc-

tion as commercial spaces, were reclassified as "civic amenities" and then allotted to members of the Kharge family without any public auction. He specifically pointed to plots that were given to a starred hotel and an apartment construction company—both of which, he argued, should have been put up for competitive bidding. "This is a flagrant violation of the rules," Narayanaswamy declared. "These CA plots are not meant for commercial purposes, yet they were handed over in clear contravention of established norms. The way these plots were allotted, under the influence of Mallikarjun Kharge, is not only unethical but illegal." The opposition leader did not stop there, accusing the government of ignoring the needs of marginalised communities. He highlighted that while the government was quick to allot land to private entities, it failed to allocate land for the Social Welfare Department to build SC and ST hostels. Narayanaswamy also raised concerns about 71

Gender equality lies beyond the paycheck. Women must turn leaders, charcha 2024 can help

The global wage gap between men and women stands as a stark testament to the pervasive gender inequalities that continue to plague economies worldwide. Despite some strides toward equality, even today, the labor force participation rate for women remains just over 50 per cent, starkly contrasted with men's 80 per cent. In India, while the wage gap has narrowed from a shocking 48 per cent in the early 1990s to 28 per cent by 2019, it continues to be a significant barrier to true gender equality.
